THE HOUSE OF REPRESENTATIVES BEGAN DEBATE ON A GRASSROOTS LOBBYING BILL IN EARLY MARCH.

THE SENATE VERSION ORIGINALLY CONTAINED SECTION 220, WHICH WAS A SERIOUS THREAT TO GRASSROOTS LOBBYING GROUPS LIKE TRADITIONAL VALUES COALITION.

220 WAS STRIPPED FROM S. 1, BUT LIBERALS IN THE HOUSE ARE EXPECTED TO INCLUDE THIS UNCONSTITUTIONAL LANGUAGE IN THEIR BILL.

THIS WILL MANDATE TONS OF UNNEEDED PAPERWORK FOR NON-PROFIT GROUPS AND INCLUDE CIVIL AND CRIMINAL PENALTIES FOR MISTAKES IN FILING!



TVC IS WORKING TO OPPOSE ANY UNCONSTITUTIONAL LANGUAGE IN A HOUSE BILL. HOW MANY HOOPS DOES CONGRESS WANT PASTORS, BLOGGERS, AND GRASSROOTS LOBBYISTS TO JUMP THROUGH?

CONGRESS IS TRYING TO SOLVE A NON-EXISTENT PROBLEM BY CHILLING FREEDOM OF SPEECH.

REQUIRING GRASSROOTS GROUPS TO FILE COMPLICATED REPORTS FIXES NOTHING. IT JUST PUTS FEAR IN THOSE WHO LOBBY THAT THEY'LL RUN AFOLLO OF THE LAW.

BY ADDING RESTRICTIVE LANGUAGE IN THE HOUSE BILL, LIBERALS WILL CHILL THE RIGHT OF THE PEOPLE TO PETITION THEIR GOVERNMENT FOR A REDRESS OF GRIEVANCES!
