### Action Alert for Judge John Roberts

Judge John Roberts has just been selected by President Bush to replace Supreme Court Justice Sandra Day O'Connor on the nation's highest Court.

President Bush has the opportunity to change the course of American history with this appointment and future appointments to the Supreme Court. The President has stated that he wants to appoint judges who will interpret, not make law.

*Our children and grandchildren will be impacted for good if the President appoints Constitutionals to the Court who respect the Constitution and our legal system. We will no longer be dominated by a liberal 5-4 majority on the Court who impose their own political views on all of us.*

Judge John Roberts is a Constitutionalist. He is a man of high integrity and is a brilliant lawyer who has argued 39 cases before the Supreme Court over the past several decades.

Judge Roberts believes his job is to faithfully interpret the Constitution and laws brought before him. It is not his role to act as a legislator by inventing laws or creating new "rights."

### We Need Constitutionals On The Supreme Court

A Constitutionalist believes that judges are not to act as legislators or tyrants who impose their own political wills upon the American people. The opposite of a Constitutionalist is a liberal activist judge who views the Constitution as "living" or irrelevant to today's culture. The activist is willing to redefine terms, impose his own political ideas, and even consult with foreign court decisions in issuing edicts.

Judge Robert Bork, a brilliant Constitutionalist, refers to these activist judges as "Our Judicial Oligarchy." Judge Bork rightly states that these activists have created moral chaos in our culture—and several of these activists are on the U.S. Supreme Court.

We urge you to contact your two U.S. Senators immediately regardless of how you think they will vote and ask that they vote

YES on Judge Roberts to become our next Supreme Court Justice. He must be given a fair up or down vote, not filibustered or subjected to a fishing expedition by radical Left organizations or Senators.

**Here are TALKING POINTS for you to use in writing a letter or calling your U.S. Senators:**

1. America needs Constitutionals on the Supreme Court and lower federal courts who will interpret the law and not legislate from the bench.
2. Liberals want to maintain a monopoly in the Courts and use the Court system to impose liberal political and social agendas upon the American people. This is undemocratic and violates the right of the people to govern them. When activists ignore the Constitution or invent new "rights," they are engaging in illegal and unethical behavior. They must be replaced.
3. Judge John Roberts has publicly stated that he is a Constitutionalist who will faithfully interpret the Constitution and the laws under consideration before the Supreme Court. He will not legislate from the bench or impose his own views in decisions.
4. The Constitution should be interpreted based on the original intent of the Founding Fathers who wrote it—not upon a judge's political ideas or thoughts about social justice.

Mark Levin, writing in his new book *Men in Black: How the Supreme Court Is Destroying America* has written: "Judicial activists are nothing short of radicals in robes—contemptuous of the rule of law, subverting the Constitution at will, and using their public trust to impose their policy preferences on society. In fact, no radical political movement has been more effective in undermining our system of government than the judiciary."
